\*The Ayurvedic Accreditation Commission (formally National Ayurvedic Medical Accreditation Council) - AAC sets competency standards for professional Ayurvedic education. HAC is not AAC-approved as its hours are below the first level benchmark set by AAC for Ayurvedic professional education. The AAC Formats of AHC and AP are the only program versions that meet the competencies required by AAC for our program graduates to be eligible to take the Board Exam offered by NAMA's Certification Board (NAMACB). All Online & Hybrid students may transition to the AAC format at an additional cost.

Kerala Ayurveda Academy's In Person AHC and AP are currently AAC Recognized programs and are in candidacy status for Accreditation with AAC.

\*\*Note: The All Online portion of the AHC will no longer be offered after the Spring 2024 session. All AHC students will be required to attend the in person requirements to graduate.

#### ■ Holistic Ayurvedic Coach (HAC)

Prerequisite: High School Diploma or Equivalent

The Holistic Ayurvedic Coach program offers an authentic introduction to Ayurveda and how it can be practically applied to an individual's life for self-improvement or career enhancement, including fundamental principles of Ayurveda, Ayurvedic physiology and psychology, nutrition, Yoga, lifestyle and seasonal protocols. The entire HAC program is the first six modules of the level I Ayurvedic Health Counselor program, which allows the HAC student an opportunity to seamlessly transition into AHC.

#### ■ LEVEL I - Ayurvedic Health Counselor (AHC)

Prerequisite: High School Diploma or Equivalent • Corequisite: Anatomy & Physiology

The level I Ayurvedic Health Counselor program builds on the HAC program topics listed above by offering study modules focused on Ayurvedic herbology, an introduction to Panchakarma detoxification, as well as disease pathology and management. Upon graduation an AHC can determine and analyze body constitution, conduct Ayurvedic lifestyle consultations, and offer guidance on daily routines, Ayurvedic therapies and home remedies.

#### ■ LEVEL II - Ayurvedic Practitioner (AP)

Prerequisite: Level I AHC • Corequisite: Anatomy & Physiology

After completing AHC, students are eligible for the level II Ayurvedic Practitioner program in which all the key clinical concepts are explored more deeply. Students learn the etiological factors contributing to the nature and structure of disease as well as management techniques.

# TRAINING LEVEL TRACKS

We offer three formats or tracks for our programs: All Online, Hybrid and AAC. These tracks are designed to offer maximum flexibility to students who choose the All Online or Hybrids Tracks, as well as a AAC Track which meets the requirements to take the Board Exams offered by the National Ayurvedic Medical Association Certification Board (NAMACB). Students who complete the All Online or Hybrid Tracks may transition to the AAC Track at an additional cost.

#### WEEKEND INTENSIVES

#### KAA 101 | The Essence of Ayurveda (Tarka Sankhya and Sharir)

Begin your education with an introduction to the 5,000-year-old history and philosophy of Ayurveda. The three universal energies (Doshas) and five fundamental elements (Mahabhutas) are the starting point for any Ayurvedic student. This leads to an understanding of the 20 foundational qualities of life (Gunas), the key to health. The application of these guiding principles will also be covered as it relates to the concepts of physiological disposition (Prakruti), imbalance (Vikruti) and Dynamic Balance. Additional topics include:

- The fundamental tenets of an effective Ayurvedic health program
- The universe and humanity's place within it: An Ayurvedic View
- The cosmology of the soul
- Comprehensive introduction to basic Ayurvedic concepts: Doshas, Dhatus, Malas, Asthis, Sandhis, Srotas

#### KAA 102 | Ayurvedic Physiology (Dosha Dhatu Mala Vigyan)

Ayurvedic Physiology is designed to describe the subtle energies and foundational structures of the human body. Ayurveda explains the formation and structure of the seven tissues of the body in detail. This course will cover the details of these seven tissues and offer a deeper look into how they work cohesively to form the structure and function of the human body. Additional topics include:

- The 15 subtle energies of the body (Subdoshas), their locations, qualities, and importance in health
- Natural wastes and their functions
- The essence of life which is responsible for vigor and youthfulness (Ojas), as well as how it is regenerated and preserved.

#### KAA 103 | Ayurvedic Psychology (Manasa Shastra)

Ayurvedic Psychology offers a fascinating look into the psychology of the human being from a cosmological and energetic perspective. This course will cover the three Gunas and how they are fundamental for understanding the mind and emotions. Additionally, the Ayurvedic study of how energy moves through the body is powerful and important to fully understand holistic human health. This course will cover the chakras and how to keep them healthy as well as the physical energy centers (Marmas) and their role in health and disease. Additional topics include:

- The psychological energies (subtle Doshas), their function, location and origin
- Kundalini energy and the mechanics of vital living
- The nature and aspects of the mind and how it functions and operates.
- Meditation and Pranayama (breathing techniques)

#### KAA 104 | Ayurvedic Nutrition & Cooking (Ahara Vigyan)

Ayurvedic Nutrition & Cooking places an emphasis on foods that ground the soul, nourish the body and delight the senses. This is a fun course with in-person cooking demonstrations teaching

how to prepare simple, nutritious and sensually gratifying meals. Ayurvedic cooking is aimed towards pleasing all five senses and experiencing all six tastes. This course will also review techniques for maximum nutrient absorption and explain how that relates to a balanced digestive system. Additional topics include:

- The mechanics of satiation and its relationship to the tastes and senses
- When, where, what and how to eat.
   The definition of health
- Chaturvidha Ahara, Shatrasas, Ahara Vidhi Vishesha, and the Guna Karma of spices

#### KAA 105 | Ayurvedic Prevention Science (Swastha Vritta)

Ayurvedic Prevention Science provides a comprehensive blueprint for daily and seasonal living to maintain optimal health, year-round. This can be done by learning the ideal Ayurvedic daily routine (*Dinacharya*) to live a balanced life and maximize effectiveness of your efforts. Additional topics include:

- Seasonal routines to maintain health and prevent allergies and seasonal infections.
- Ways to stay healthy year-round by supporting a strong immune system.
- How a modification or change in your daily routine according to the season will impact your health

#### KAA 106 | Ayurveda and Yoga (Yoga Vigyan) and Clinical Practice (3 days)

Ayurveda and Yoga will focus on understanding the principles of Yoga in connection with the Ayurvedic concepts. The course will begin with a detailed understanding of the eight limbs of Yoga and the koshas in connection with Yoga and Ayurveda. This course will also teach students how to customize each yoga practice based on the individual's constitution. Additional topics include:

- How Yoga and Ayurveda combined can create the foundation for a transformed experience of living
- Yoga and Ayurveda to deepen your spiritual practice.
- Pranayama and meditation techniques

# 1-DAY CLINICAL PRACTICUM

This small group practical provides the opportunity to practice clinical techniques with supervised guidance, honing coaching skills utilizing all the tools learned thus far.

# TUESDAY VIRTUAL CLASSES

Virtual Classes covers topics in alignment with the upcoming or recent Weekend Intensive. These sessions offer students opportunities to explore topics raised in the Weekend Intensives in more depth, such as *Doshas* (one of the core principles of Ayurveda), *Ahara* (the inputs of life) and *Dinacharya* (daily and nightly rituals).

With this certificate, students are able to counsel clients for wellness. This program does not lead to positions that would require licensing in this field, as there is no required licensing for Ayurveda at this time.

- Suggest dietary changes (explain Ayurvedic view about qualities and 6 tastes)
- Suggest daily routine changes (explain daily predominance of Doshas at different times)
- Suggest seasonal routine (explain seasonal predominance of Doshas)
- Suggest life cycle routine (explain life cycles and predominance of Doshas)
- Explain about Ayurvedic concepts (related to Prakriti, Vikriti, qualities, etc.)
- Explain the connection between Body and Mind and how diet and lifestyle, meditation, Pranayama can help prevent many emotional problems.
- Offer talks and write articles on various concepts on Ayurveda
- Suggest basic oil therapies
- Offer cooking classes using Ayurvedic recipes along with techniques and tips to create Ayurvedically balanced meals
- Suggest common herbs and spices

# Curriculum

The Ayurvedic Health Counselor training program covers both theoretical and practical training, including a blend of online learning, in person hands-on training experience, clinical encounters and assignments. Live classroom sessions and hands-on practicums are supplemented by online recorded lectures.

### LEARNING MATERIALS & RESOURCES

- Course manuals: digital manuals are provided for each Weekend Intensive module.

- Elearning: learn anytime, anywhere, at your own convenience on your own computer. Our AHC training program content is made available to students online via our elearning platform powered by TalentLMS. Elearning provides access to course information, live class recordings, assignments, online recorded lectures, course manuals, class slides, pretests and tests.

#### WEEKEND INTENSIVES

#### KAA 101 | The Essence of Ayurveda (Tarka Sankhya and Sharir)

Begin your education with an introduction to the 5,000-year-old history and philosophy of Ayurveda. The three universal energies (*Doshas*) and five fundamental elements (*Mahabhutas*) are the starting point for any Ayurvedic student. This leads to an understanding of the 20 foundational qualities of life (*Gunas*), the key to health. The application of these guiding principles will also be covered as it relates to the concepts of physiological disposition (*Prakruti*), imbalance (*Vikruti*) and Dynamic Balance. Additional topics include:

- The fundamental tenets of an effective Ayurvedic health program
- The universe and humanity's place within it: An Ayurvedic View
- The cosmology of the soul
- Comprehensive introduction to basic Ayurvedic concepts: Doshas, Dhatus, Malas, Marmas, Asthis, Sandhis, Srotas

#### KAA 102 | Ayurvedic Physiology (Dosha Dhatu Mala Vigyan)

Ayurvedic Physiology is designed to describe the subtle energies and foundational structures of the human body. Ayurveda explains the formation and structure of the seven tissues of the body in detail. This course will cover the details of these seven tissues and offer a deeper look into how they work cohesively to form the structure and function of the human body. Additional topics include:

- The 15 subtle energies of the body (Subdoshas), their locations, qualities and importance in health
- Natural wastes and their functions
- The essence of life that is responsible for vigor and youthfulness (Ojas), as well as how it is regenerated and preserved

# KAA 103 | Ayurvedic Psychology (Manasa Shastra)

Ayurvedic Psychology offers a fascinating look into the psychology of the human being from a cosmological and energetic perspective. This course will cover the three *Gunas* and how they are fundamental for understanding the mind and emotions. Additionally, the Ayurvedic study of how energy moves through the body is powerful and important to fully understand holistic human health. This course will cover the chakras and how to keep them healthy as well as the physical energy centers *(Marmas)* and their role in health and disease. Additional topics include:

- The psychological energies (subtle *Doshas*), their function, location and origin
- Kundalini energy and the mechanics of vital living
- The nature and aspects of the mind and how it functions and operates
- Meditation and Pranayama (breathing techniques)

#### KAA 104 | Ayurvedic Nutrition & Cooking (Ahara Vigyan)

Ayurvedic Nutrition & Cooking places an emphasis on foods that ground the soul, nourish the body and delight the senses. This course teaches how to prepare simple, nutritious and sensually

gratifying meals. Ayurvedic cooking is aimed towards pleasing all five senses and experiencing all six tastes. This course will also review techniques for maximum nutrient absorption and explain how that relates to a balanced digestive system. Additional topics include:

- The mechanics of satiation and its relationship to the tastes and senses
- When, where, what and how to eat
- The definition of health
- Chaturvidha Ahara, Shatrasas, Ahara Vidhi Vishesha, and the Guna Karma of spices

#### KAA 105 | Ayurvedic Prevention Science (Swastha Vritta)

Ayurvedic Prevention Science provides a comprehensive blueprint for daily and seasonal living to maintain optimal health, year-round. This can be done by learning the ideal Ayurvedic daily routine (*Dinacharya*) to live a balanced life and maximize effectiveness of your efforts. Additional topics include:

- Seasonal routines to maintain health and prevent allergies and seasonal infections
- Ways to stay healthy year-round by supporting a strong immune system
- How a modification or change in your daily routine according to the season will impact your health

#### KAA 106 | Ayurveda and Yoga (Yoga Vigyan)

Ayurveda and Yoga will focus on understanding the principles of Yoga in connection with the Ayurvedic concepts. The course will begin with a detailed understanding of the eight limbs of Yoga and the koshas in connection with Yoga and Ayurveda. This course will also teach students how to customize each yoga practice based on the individual's constitution. Additional topics include:

- How Yoga and Ayurveda combined can create the foundation for a transformed experience of living
- Yoga and Ayurveda to deepen your spiritual practice
- Pranayama and meditation techniques

#### KAA 107 | Ayurvedic Herbology (Dravya Guna Shastra)

Ayurvedic Herbology marks the halfway point in your Ayurvedic Health Counselor education. This detailed class will introduce the concepts of herbal energetics and how to identify the healing properties of household herbs. There will be a comprehensive analysis of herbal characteristics such as taste, potency, post-digestive effect and what they mean for your health. Special emphasis will be placed on over twenty different Ayurvedic herbs such as Amla, Brahmi, Neem and Shatavari. Additional topics include:

- Herbs to boost the immune system, delay aging and improve the quality of life
- How to maximize the absorption of herbs and medicines
- Preparing and administering specialized herbs and herbal concoctions
- Popular formulations and recipes

#### KAA 108 | Introduction to Ayurvedic Bodywork (Panchakarma)

Introduction to Ayurvedic Bodywork will focus on hands-on techniques to promote cellular healing and regeneration. This course will cover simple body therapies that have an anti-aging effect, improve digestive absorption, calm the mind and improve sleep. Additional topics include:

- Daily therapies to promote healing and wellness
- Treatments to improve skin tone and luster while also soothing the nervous system
- A hands-on introduction to Snehana, Swedana, Shirodhara, Padabhayanga,
   Shiroabhyanga, Kati Basti, Lepas, Udvartana and Soundarya Shringar

### KAA 109 | Assessment of Dosha Imbalances (Roga Nidan)

Assessment of Dosha Imbalances will describe how diseases form and progress, how an individual can spring from health to imbalances. This course will cover simple ways to identify warning signs long before they become full-blown symptoms. Additional topics include:

- The Ayurvedic energies and structures (Dosha, Dhatu, Mala) and their role in the disease process
- How to analyze the various systems and structures of the body and identify potential warning signs: tongue, pulse and mala diagnosis
- In-depth examination of case studies

#### KAA 110 | Management of Dosha Imbalances (Kaya Chikitsa)

Management of Dosha Imbalances will describe how to address various imbalances and how to prevent their progression. This course will introduce the unique etiopathogenesis that Ayurveda uses to explain energies and structures (*Dosha, Dhatu, Mala*) and their role in various etiopathogenesis. The evolution of diseases through various Dosha stages reaching the final degenerative phase. Additional topics include:

- Simple ways to identify warning signs and methods of arresting the disease progression.
- Tools and techniques including simple herbal treatments and dietary & lifestyle changes to restore and maintain equilibrium
- Various methodologies involved in Palliative (Shamana) and Purification (Shodhana) treatments

## KAA 111 | Review, Clinical Management

Review and Clinical Management will take a final look at the prior ten months in a summarized review and investigate Ayurveda's application in modern times. Students will be guided on how to build and sustain clinical practice and how the science of Ayurveda applies to the business model. The highlights of the class are consultation demonstrations and practice for the students.

## AHC PRACTICAL IMMERSIONS

These intensives focus on the main Ayurvedic Lifestyle recommendations and are taught under the guidance of an Ayurvedic Doctor (Vaidya).

## AHC Practical Immersion 1 (coincides with KAA 107)

This 5-day practicum (including weekend module KAA 107), covers Ayurvedic cooking, herbology and a detailed review of the client intake process. It covers how to utilize information from the healthy history intake, principles and practice of individual constitution (Prakriti) assessment, plus guided counseling with live cases.

## AHC Practical Immersion 2 (coincides with KAA 111)

This 5-day practicum (including weekend module KAA 111) reviews the process from client intake through final recommendations. It offers many practice sessions with live case consultations, and exploration of the practical ways in which this training can be implemented.

Required in person attendance for AAC Track. Online & Hybrid students may attend future sessions to meet AAC Track requirements.

### 1-DAY CLINICAL PRACTICUM

A small group practical setup provides the opportunity to practice clinical techniques with supervised guidance, honing counseling skills utilizing all the tools learned thus far.

## TUESDAY VIRTUAL CLASSES

Tuesday Virtual Classes are offered live approximately twice per month, covering topics in alignment with the upcoming or recent Weekend Intensive. These sessions offer students opportunities to explore topics raised in the Weekend Intensives in more depth, such as *Doshas* (one of the core principles of Ayurveda), *Ahara* (the inputs of life) and *Dinacharya* (daily and nightly rituals).

## MONDAY VIRTUAL CLASSES

There are six Monday Virtual Classes. These sessions will cover topics on Business and Ethics.

## ONLINE RECORDED LECTURES

Online Recorded Lectures are included in each monthly module, covering topics in alignment with the Weekend Intensives.

## Ashtanga Hridayam

#### Part 1: The Quest for Longevity: Foundational Principles of Ayurveda

#### Part 2: Daily Regimen for Health and Longevity

Class recordings of the first two sessions of our *Ashtanga Hridayam* online series (offered live twice per year) are included in the Online Recorded Lectures to provide students with a rich learning experience straight from the Vedic texts. *Ashtanga Hridayam* is one of the most used root texts of Ayurveda today. Composed in a beautiful poetic format called *Sutras* for easy memorization by practitioners, each line of the text is filled with practical information. Students learn the text line-by-line, how to chant the Sanskrit and understand the deeper meaning behind the principles.

## AAC TRACK: AHC CLINICAL INTERNSHIPS

AHC Clinical Internships include clinical consultations, which are a combination of observing the faculty conducting a consultation and student-conducted in person consultations under faculty supervision. The goal of this training is to reinforce learned concepts with applied applications in a clinical setting, with many opportunities to ask questions and receive mentored guidance.

## **ASSIGNMENTS**

To support your development as an Ayurvedic Health Counselor, assignments are included in the AHC program which build upon each module of learning, and each another.

## Personal Transformation Journey

Healing begins right at home for the healer. When we learn to work with Ayurveda to bring healing to our own lives, we can ground our knowledge in first-hand experience and better support others in doing the same. This assignment involves a self-assessment and experiential process of implementing the Ayurvedic principles and practices learned in class.

## Ayurvedic Constitution Assessments

Each student will conduct in person one-on-one constitution assessments with ten (10) people utilizing intake forms provided by KAA to practice skills in client interactions, assessment and documentation. This assignment is completed during the HAC portion of your program.

#### Clinical Consultations

Students will follow two (2) Rogis (clients) throughout the program until KAA 111, beginning with consultations and progressing with assessment and creating guidance based on the topics

covered in each month. This offers the student the ability to build upon all the learning to create a case study approach.

#### Chikitsa Protocols

Students will be provided five (5) case papers for review and development of a comprehensive Ayurvedic chikitsa protocol to demonstrate the cumulative skills learned in case evaluations from the previous two assignments.

## Research Project: Community Health Presentation **OR** Research Paper

Students have the choice of a Community Health Presentation or Research Paper.

#### **Community Health Presentation Description**

Students will prepare a 1-1.5 hour presentation for a group in the community on an approved topic of student's choice. Students may host and organize the event for personal contacts or offer in conjunction with a greater organization (e.g., a Yoga studio), or arrange to deliver this presentation at an office, school or other place of business.

#### OR

#### **Research Paper Description**

Students will prepare a 5–7-page paper on an approved topic within the scope of practice as an Ayurvedic Health Counselor.

# Ayurvedic Practitioner (AP)

## 910 HOUR TRAINING PROGRAM

The Ayurvedic Practitioner (AP) program is based on the second goal of Ayurveda—*Aaturasya Vikara Prashamanam* (disease management). At this level, the emphasis is on gaining a deeper understanding of the disease process and management techniques at its various stages. Students will gain a deeper understanding of Ayurvedic concepts and techniques.

Upon successful completion of the AP Program, you will be awarded an Ayurvedic Practitioner Certificate.

## **Program Overview**

## SCOPE OF PRACTICE

With this certificate, students gain the skills and knowledge to assess the Ayurvedic constitution and imbalances in a client and suggest food, lifestyle changes and recommend Ayurvedic herbs, spices and Ayurvedic herbal supplements based on the Samprapti/imbalances. However, the practice of these may vary from state to state. Please check the regulations with the state in which you practice. This program does not lead to positions that would require licensing in this field, as there is no required licensing for Ayurveda at this time.

## Ayurvedic Practitioners can:

- Analyze Body Constitution
- Complete health history intake
- Assess the imbalances of Agni, Dosha, and Strotases based on the Ayurvedic Principles
- Suggest food and lifestyle changes based on the Ayurvedic Constitution (Prakriti) and various imbalances in the mind/body systems (Vikriti)
- Suggest Ayurvedic herbs, spices and Ayurvedic herbal supplements based on the Ayurvedic Constitution (*Prakriti*) and various imbalances in the mind/body systems (*Vikriti*)
- Suggest Ayurvedic bodywork techniques based on the Ayurvedic Constitution (Prakriti) and various imbalances in the mind/body systems (Vikriti)
- Explain about Ayurvedic concepts (related to Prakriti, Vikriti, qualities etc)
- Explain the connection between Body and Mind and how diet and lifestyle, meditation, Pranayama, Ayurvedic herbs, Ayurvedic bodywork techniques and Yoga can help manage many physical, mental and emotional problems
- Offer talks/write articles on various concepts on Ayurveda
- Offer simple Ayurvedic bodywork techniques based on the Ayurvedic Constitution (Prakriti) and various imbalances in the mind/body systems (Vikriti)
- Offer cooking classes giving simple cooking tips

## Ayurvedic Practitioners cannot:

- Diagnose diseases medically
- Treat diseases medically
- Prescribe medical treatments or medicines
- Perform Panchakarma (unless allowed in your scope of practice under other licensing)

### **PREREQUISITES**

It's essential for Ayurvedic students in professional programs to have adequate knowledge of Anatomy and Physiology (A&P). As a condition of graduation from the AP program, the equivalent of six (6) college-level A&P credits (90 hours) is required. (A&P credit completion is not required prior to enrollment, it may be taken as a corequisite alongside the AP program). KAA offers an online partner A&P course, or you can provide documentation of A&P credit completion from an approved institution. Please visit our website to learn more about our partner course or to submit your documentation.

#### AP AAC Track

- KAA AHC AAC Track graduates can enter the AP program directly.
- KAA AHC Online and Hybrid Track graduates must meet all AHC AAC Track standards before enrolling in the AP AAC Track.

The Ayurvedic Accreditation Commission (AAC) sets competency standards for professional Ayurvedic education. ## Curriculum

The Ayurvedic Practitioner training program covers both theoretical and practical training, including a blend of online learning, in person hands-on training experience, clinical encounters and self-paced assignments. Live classroom sessions and hands-on practicums are supplemented by online recorded lectures on our elearning platform.

### WEEKEND INTENSIVES

# KAA 201 | Advanced Anatomy, Physiology & Basic Principles (Dosha Dhatu Mala Vigyan)

Includes an in-depth discussion of the *Doshas, Subdoshas, Dhatus, Malas, and Agni*. Greater emphasis is placed on the *Srotas, Kalas and Marmas*. This course also includes a deep exploration of the basic principles directly from the scriptures such as the *Soothrasthana* of *Ashtanga Hridayam*. Additional topics include:

- An overview of embryology
- The relationship between the Panchabhutas and the Gunas
- An introduction to the fascinating world of Marma Sareera, seats of Prana in the body

# KAA 202 | Pathophysiology & Ayurvedic Diagnostic Methods (Advanced Nidan & Rogi Pariksha)

Includes a detailed exploration of the five stages of disease identification: *Nidan, Purvaroop, Roopa, Upashaya, and Samprapti.* This course also looks at the six stages of the disease process: *Sanchaya, Prakopa, Prasara, Sthanasamshraya, Vyakti and Bheda.* Students will gain an understanding of the signs of *Dhatu* and *Srota Dushti.* Students will delve deeply into Ayurvedic client examination methods. Topics include:

- An understanding of the stages from health to disease
- Threefold client examination (Darshana, Sparshana, and Prashana)
- Eight-fold clinical evaluation (Pulse, Tongue, Voice, Physical Stature, Vision, Skin, Urine, and Bowel)

# KAA 203 | Advanced Herbology & Ayurvedic Pharmaceutics (Dravya Guna & Bhaishajya Kalpana)

Expands upon the principles of Ayurvedic herbal energetics, actions, uses and preparations with over thirty additional herbs. Learn the preparation of popular Ayurvedic formulations and their clinical application, times of administration and Anupanas, measurements and dosage of Ayurvedic herbs and formulations. Topics include:

- Preparation of Formulations: Decoctions, Herbal Oils, Ghees, Pastes, Poultices, Pills,
   Powders & Jams
- An understanding of how an herb's Gunas affect the body
- Traditional preparation of buttermilk & ghee from milk

## KAA 204 | Advanced Bodywork, Detoxification & Rasayana (Panchakarma & Rasayana)

Advanced Bodywork, Detoxification and *Rasayana* is a hands-on course. A detailed theory of Panchakarma will be covered, including the *Poorvakarma* (Preparation), *Pradhanakarma* (Main Procedure) and *Paschatkarma* (Post-Procedural Convalescence). The preparatory procedures, including various types of *Snehana* & *Swedana* therapies, will be explained. This course also covers the five Ayurvedic Detoxification procedures. The post Panchakarma convalescence, such as specific food and lifestyle modifications, is also a part of this course. Topics include:

- Snehana & Swedana Therapies Abhyanga, Choornasweda, Patrapotala Sweda,
   Njavarakizhi, Pizhichil, Udwartanam, Kateevasthy, Nethratharpanam, Lepam, Pichu
- Panchakarma: Vamana, Virechana, Anuvasana, Niroohavasthy, Nasya
- Various aspects of Rasayana the anti-ageing modalities of Ayurveda

#### KAA 205-208 | Kayachikitsa I-IV

Each Kayachikitsa course I, II, III and IV will cover the following topics for their course theme:

- Nidana and Samprapti
- Ayurvedic Clinical Assessment
- Management Protocol
- Preparation of Specific Formulations

## KAA 205 | Kayachikitsa I: Management of Digestive System & Metabolic Disorders

The course will cover Ayurvedic etiology, pathogenesis, symptoms, signs, and detailed herbal treatments, as well as dietary and lifestyle changes, for several digestive and metabolic disorders.

## KAA 206 | Kayachikitsa II: Management of Nervous System & Musculoskeletal Disorders

This course will cover Ayurvedic etiology, pathogenesis, symptoms, signs, detailed herbal treatments and dietary and lifestyle changes for several nervous systems and musculoskeletal disorders. This course also covers fracture management and bandages.

# KAA 207 | Kayachikitsa III: Management of Respiratory System & Cardiovascular System Disorders

This course covers Ayurvedic etiology, pathogenesis, symptoms, signs, detailed herbal treatments and dietary and lifestyle changes for several respiratory, circulatory and cardiac disorders.

## THURSDAY VIRTUAL CLASSES

These sessions offer students opportunities to explore topics raised in the Weekend Intensives in more depth, such as Clinical Management of *Ama*, Pain Management in Ayurveda and Samprapti & Case Papers.

### ONLINE RECORDED LECTURES

Online Recorded Lectures are included in each monthly module, covering topics in alignment with the Weekend Intensives and include the following:

## Vedic Formulations: Clinical Applications

One of the important skills of an Ayurvedic Practitioner is the ability to select the right herbs and formulations for an individual's constitution and imbalances. In these recordings, you will learn the most used and effective Vedic formulations as documented in the classical texts. The class will cover multiple formulations and single herbs. Students receive an overview of the formulation, contents of the formulations, method of preparation, specific indications, dosage forms, and appropriate adjuvants. Part one of this series is included as a recording and quiz in your AP Program in your elearning platform.

## Ashtanga Hridayam

The Ashtanga Hridayam, the "Heart or Essence of all the Eight Branches of Ayurveda," is one of the primary ancient root texts of Ayurveda. Today, the Ashtanga Hridayam continues to serve as a root source for Ayurvedic philosophy and protocol, providing clear guidelines in all aspects of health.

As an Ayurveda student, it is important to use the authentic teachings of the ancient Vedic texts. As part of your AP training, the recordings of Parts 3 -7 of our Ashtanga Hridayam series are included.

## MONTHLY REVIEW SESSIONS

These sessions are held after the weekend intensive modules to review the content covered in the previous intensive class. There will be time for review, questions and discussions on the class content.

## **CLINICAL CASE DISCUSSIONS**

This program is dedicated to interactive reviews of clinical conditions, including cases submitted by participants. ## Grading and Graduation Requirements

## Grading

- Grading is based on a cumulative pass/fail mark from the following course components:
  - Assignments are reviewed on a pass/fail basis and are submitted in the elearning platform. Project and assignment grades are posted within 10 days of submission.

**Example**: Student paid \$8,650 at the time of enrollment

Step 1 \$8,750 – \$100 \$8,650.00

Total refund will be: \$8,650.00

#### Refund calculation seven days after enrollment or after May 12, 2024

Step 1 Deduct \$100 (registration fee) from the total tuition paid

Step 2 Divide the total tuition paid by 10 (number of modules) = 'tuition per module'

Step 3 Multiply number of classes attended or modules accessed in elearning by 'tuition per module'

Step 4 Subtract the amount in step 3 from the amount in step 1. This is the refund amount.

**Example:** if the student decides to withdraw after completing 4 in person intensives or live streaming and if he/she has paid the full tuition, the refund will be as follows:

Total refund will be: \$5,190.00

**Refunds** will be issued within 30 days of the date of student notification, or date of school determination (withdrawn due to absences or other criteria as specified in the school catalog), or in the case of a student not returning from an authorized Leave of Absence (LOA), within 30 days of the date the student was scheduled to return from the LOA and did not return.

#### State of Washington (All students not residing in California)

**Five-Day Cancellation:** An applicant who provides written notice of cancellation within five days (excluding Saturday, Sunday and federal and state holidays) of signing an enrollment agreement is entitled to a refund of all tuition paid. No later than 30 days after receiving the notice of cancellation, the school shall provide a 100% refund of tuition and fees paid.

**Other Cancellations:** An applicant requesting cancellation more than five days after signing an enrollment agreement and making an initial payment, but prior to entering the school, is entitled to a refund of all monies paid *(minus the registration fee of \$100).* 

**Rejection:** An applicant rejected by the school is entitled to a refund of all monies paid.

#### **Refund Policy Defined - WA**

The school must refund all money paid if the applicant is not accepted. This includes instances where a starting class is canceled by the school. The school must refund all money paid if the applicant cancels within five business days (excluding Sundays and holidays) after the day the contract is signed or an initial payment is made, as long as the applicant has not begun training.

The school may retain an established registration fee equal to ten percent of the total tuition cost, or \$100, whichever is less, if the applicant cancels after the fifth business day after signing the contract or making an initial payment. A "registration fee" is any fee charged by a school to process student applications and establish a student record system.

If training is terminated after the student enters classes, the school may retain the registration fee plus a percentage of the total tuition as described as follows:

When calculating refunds, the official date of a student's termination is the last day of recorded attendance:

- When the school receives notice of the student's intention to discontinue the training program; or,
- When the student is terminated for a violation of a published school policy which provides for termination; or,
- When a student, without notice, fails to attend 2 consecutives in person intensives or fails to access online modules for ninety calendar days.

All refunds must be paid within thirty calendar days of receiving a completed and signed Kerala Ayurveda official refund request form and the student's official termination date.

Eligible refunds will not include the applicable interest during the enrollment period.

**Example:** if the student decides to withdraw after completing 2 classes or after accessing the 4th online module and if they have paid the full tuition, the refund will be as follows:

# Student Tuition Recovery Fund (STRF)

#### FEE (NON-REFUNDABLE) - STATE OF CALIFORNIA

"The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

"It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 1747 N. Market Blvd. Ste 225, Sacramento, CA 95834, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

- The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
- You were enrolled at an institution or a location of the institution within the 120-day period before the closure of the institution or location of the institution or were enrolled in an educational program within the 120-day period before the program was discontinued.
- You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
- The institution has been ordered to pay a refund by the Bureau but has failed to do so.
- The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
- You have been awarded restitution, a refund, or other monetary award by an arbitrator
  or court, based on a violation of this chapter by an institution or representative of an
  institution, but have been unable to collect the award from the institution.
- You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF. A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law. However, no claim can be paid to any student without a social security number or a taxpayer identification number."

#### FEE - STATE OF WASHINGTON

# Academy Policies

#### FOR ALL PROGRAMS

#### **DIVERSITY & RELIGIOUS ACCOMMODATION**

Kerala Ayurveda Academy encourages diversity and accepts applications from all. Kerala Ayurveda Academy does not discriminate on the basis of race, creed, color, national origin, sex, veteran or military status, sexual orientation, or the presence of any sensory, mental, or physical disability or the use of a trained guide dog or service animal by a person with a disability. Kerala Ayurveda Academy acknowledges that information pertaining to an applicant's disability is voluntary and confidential and will be made on an individual basis. If this information is presented, Kerala Ayurveda Academy will reasonably attempt to provide accommodation to overcome the effects of the limitation of the qualified applicant. All inquiries about accommodations should be made to the admissions administrator upon registration of the program.

Kerala Ayurveda Academy will make good faith efforts to provide reasonable religious accommodations to students who have genuinely held religious practices or beliefs that conflict with a scheduled program requirement. Students requesting a religious accommodation should make the request, in writing, directly to Student Support (support@keralaayurveda.us) with as much advance notice as possible. Absence from class does not excuse students from keeping up with any information shared or expectations set during the missed class. Students are responsible for reviewing the class recording and obtaining information provided during any class missed. The student shall work with their assigned Student Mentor to determine a schedule for making up missed work.

Examples of religious accommodations made by KAA may include rescheduling of an exam or giving a make-up exam for the student in question; altering the time of a student's presentation; allowing extra-credit assignments to substitute for missed class work or arranging for an increased flexibility in assignment due dates; and releasing a graduate assistant from teaching or research responsibilities on a given day.

#### ATTENDANCE POLICY

Kerala Ayurveda Academy accepts a limited number of students for in person attendance in the live class at 691 S. Milpitas Ave #206, Milpitas, CA. Student attendance is limited to 45 individuals. The instructor to student ratio is 1:45.

Attendance is monitored both in person and during live streamed sessions. A student will be assessed for dismissal from the institution if the student has not attended any class for the first quarter of their program. They will be notified by email in their elearning system and subsequently dismissed with no response. (See Termination Policy)

#### Holistic Ayurvedic Coach (HAC)

**All Online and Hybrid** students must attend 105 hours of in person and/or live synchronous sessions together (live synchronous refers to live streaming attended in real time). *There is a total of 149 available in person and/or live synchronous hours.* 

#### Ayurvedic Health Counselor (AHC)

**All Online, Hybrid, and AAC Track** students must attend a minimum of 240 in person and/or live synchronous sessions together (live synchronous refers to live streaming attended in real time). There is a total of 336 available in person and/or live synchronous hours.

Online and Hybrid Track students who want to transition to AAC Track must complete the 90 hours of Practical Immersion in person and attend the two AHC Internships in person (46 hours each, for a total of 92).

**AAC Track** students must attend the 90 hours of Practical Immersion in person and attend the two AHC Internships in person (46 hours each, for a total of 92).

#### Ayurvedic Practitioner (AP)

**All Students** must attend 230 hours of Clinical Internship and 45 hours of Practical Immersion (this includes KAA210 weekend class) in person. There is a total of 437 in person hours available.

**All Students** must attend a minimum of 180 live synchronous sessions (live synchronous refers to live streaming attended in real time).

**Hybrid Track** students who want to transition to AAC Track must attend 85 additional hours of in person training (see *Transition to AAC Track*).

#### MAKE-UP AND RETAKE POLICY

If a student is absent from an in person or live streamed session, they may make it up at any KAA training location or via live streamed session, free of charge. If a student wishes to retake an inperson session, they may do so for a fee of \$50 per day. To plan for all make-up or retake sessions, please contact Student Support at <a href="mailto:support@keralaayurveda.us">support@keralaayurveda.us</a>.

#### PRACTICAL IMMERSION POLICIES

Practical Immersions occur twice per year. Students are encouraged to attend each Immersion with their respective class, but if they cannot make it, they can attend the next class session, pending availability.

Each Practical Immersion is scheduled in association with a specific AHC or AP Weekend Intensive and is designed to provide optimal hands-on learning to complement the curriculum up to the date of the Immersion. Priority registration is initially limited to students from that Practical Immersion's respective AHC/AP session. After the priority registration deadline ends, students & alumni from previous AHC/AP sessions can register.

#### Practical Immersion Attendance

Students who are unable to attend the Practical Immersion during your program may attend a future Immersion within a year after the end date of your program at no additional charge.

#### Transition to AAC Track

**Within 1 year of program end date:** All Online and Hybrid Students who attended the Practical Immersion online and who wish to transition to the AAC Track may attend a future Immersion after the end date of their program, at no additional charge. This is valid for up to one year.

**After 1 year from program end date:** All Online and Hybrid Students who decide to attend an Immersion beyond the one-year limit are responsible for a nonrefundable fee of \$160 per day.

Students are responsible for informing Student Support Services (support@keralaayurveda.us) via email of their intent to attend in-person Immersions at least 90 days in advance. Payment is required to confirm your reservation.

#### Practical Immersion Retake Fee

All students who attended the Practical Immersion online or in person and who wish to retake the Practical Immersion online or in person may attend a future Immersion, are responsible for a nonrefundable fee of \$160 per day.

#### Practical Immersion Registration Requirements

**Online students - Current Students:** Student Support Services will request Current Students to confirm their online attendance in advance.

In person registration - Current Students: Current Students in a program who plan to attend the Immersion in person are responsible to inform Student Support Services (support@keralaayurveda.us) via email of their intent to attend their assigned Immersions at least 90 days in advance to guarantee placement.

In person registration - Retake or AAC Transition Students: Students who plan to retake the Immersion online or in person are responsible for informing Student Services via email of their intent to attend and in which track. If payment is required, it is due to confirm the registration and guarantee placement. Immersion retake payments are nonrefundable but transferrable to another Immersion.

#### LENGTH OF TIME FOR STUDENT TRAININGS

**HAC** Students are expected to complete the program prior to the date listed in the schedule, however they can apply for a 6-month extension to complete for a total of 12 months. **AHC** Students are expected to complete within 1 year, however they can apply for a 6-month extension to complete for a total of 18 months. **AP** Students are expected to complete within 1.5 years; however, they can apply for a 9-month extension for a total of 27 months.

If a student has not completed the program within the extension period, the student will be considered on involuntary sabbatical (see below).

#### STUDENT SABBATICAL (LEAVE OF ABSENCE)

If a student has circumstances that prevent them from continuing the program as originally planned, they may apply for a one-time Sabbatical. The Sabbatical will be requested by the student to the Student Support Office at <a href="mailto:support@keralaayurveda.us">support@keralaayurveda.us</a>. The office will then send a form for the student to complete and sign.

#### There are two types of Student Sabbatical.

#### Voluntary Sabbatical

 When a student has circumstances that prevent them from continuing the program as originally planned.

A \$100 Change of Agreement fee is incurred to take a Voluntary Sabbatical.

Voluntary sabbatical students will be allowed to return to class before, or up to one year from their sabbatical. They will retain access to classes they have paid for and attended. If needed and with permission from the school, the student will be allowed to transfer into the next class at the level where the sabbatical was initiated. If the student fails to return within this one year agreed upon Sabbatical Period they will automatically be dismissed from the program, and no applicable refunds will be given.

#### Involuntary Sabbatical

A student is considered on Involuntary Sabbatical when a student has extended the length of time of their course, and still has not completed.

Involuntary Sabbatical students will need to apply for re-admission to their previous course. They will also need to sign a Re-Admission contract with Student Support Services describing their program outline and fees\* to activate their course.

\*A \$500 Re-Admission fee will be charged for an additional **6-month extension** to complete the course requirements..

To resume the program, a student must notify the school (Student Support Services at support@keralaayurveda.us or +1 (888) 275-9103, ext. 20) of their intention to resume classes and be in good academic and financial standing.

#### TERMINATION AND DISMISSAL POLICY

- If the course is terminated after the student begins classes, the Academy may retain a percentage of the total tuition as described in the Refund Policy.
- A student will be assessed for dismissal from the institution if the student has not attended any class for the first quarter of their program. They will be notified by email in their elearning system and subsequently dismissed with no response.
- For a student who is on authorized Sabbatical, the withdrawal date is the date the student was scheduled to return from Leave and failed to do so.
- For nonpayment issues: verbal and written warnings will be sent from Student Support Services. After a minimum of 3 attempts within 3 months and no response from the student, the student will be immediately dismissed.

#### SUSPENSION POLICY

There are disciplinary guidelines to provide an environment to learn and grow independently, which give students rights and responsibilities.

- Any behavior disruptive to other students or the smooth running of the class will not be allowed.
- Students will have to pay the tuition on time; this includes one-time fees and payment plans.
- Students must maintain a passing grade of 70%.

For behavioral issues: At first incidence, warning will be given. At the second incident, the student will be suspended for the entire weekend. A student will be readmitted after a suspended

weekend. If the behavior persists, the student will be dismissed (terminated) from the program. When the conduct of the student threatens the other student's safety, KAA reserves the right to dismiss a student immediately.

#### CONDUCT

At KAA, programs are directed toward professional training. The students shall show respect to others and observe correct standards of conduct. The Honor System embodies values of personal integrity, honesty, and trust.

Fundamental to the Honor System is the Honor Code of Responsibility, and it is upon its principles that the Academy has based the Standards of Conduct.

#### **Honor Code of Responsibility**

- Each member is responsible for maintaining a high level of civility, integrity, honesty, and trust within the community.
- Each student is responsible for presenting work of their own creation and refraining from representing work that which is not theirs.
- Conduct in keeping with the attendance policies.

Nothing in the policy prevents the student from contacting the Washington Workforce Board at 360-709-4600 at any time with a concern or complaint.

#### **FINANCIAL AID**

Kerala Ayurveda Academy does not offer state or federal financial aid to students. If a student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student has received federal student financial aid funds, the student is entitled to a refund of the monies not paid from federal student financial aid program funds.

If a student is eligible for a loan guaranteed by the federal or state government and the student defaults on the loan, both of the following may occur:

- The federal or state government or a loan guarantee agency may act against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
- The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid.

"**Notice -** Any holder of this consumer credit contract is subject to all claims and defenses that the debtor could assert against the seller of the goods or services obtained pursuant hereto or with the proceeds hereof, recovery hereunder by the debtor shall not exceed amounts paid by the debtor hereunder."

"Kerala Ayurveda Academy does not have a pending petition in bankruptcy, is not operating as a debtor in possession, has not filed a petition within the preceding five years, and has not had a

petition in bankruptcy filed against it within the preceding five years that resulted in reorganization under Chapter 11 of the United States Bankruptcy Code (11USC. Sec. 1101 et seq.)."

# ENGLISH AS A SECOND LANGUAGE & FOREIGN STUDENTS

Foreign students are accepted, however, KAA courses are instructed in English and KAA does not offer English as a second language. Foreign students are required to have proof of English proficiency with a passing score of minimum 80% on the TOEFL exam for enrollment. Visa services are not provided, and Kerala Ayurveda Academy will not vouch for student status and any associated charges.

#### RECORD RETENTION

All records concerning the Kerala Ayurveda Academy are kept for fifty years after student's completion, withdrawal or termination, except for transcripts which are kept permanently. Students requesting copies of these documents must submit a signed letter to the above address for the attention of Student Support.

#### TRANSFERRING OF CREDITS & CREDENTIALS

"NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT KERALA AYURVEDA ACADEMY. The transferability of credits you earn at Kerala Ayurveda Academy is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn for any KAA program is also at the complete discretion of

the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you seek to transfer after attending Kerala Ayurveda Academy to determine if your certificate will transfer."

KAA has not entered into an articulation or transfer agreement with any other college or university.

Transfer credit may be awarded for applicable coursework of comparable programs completed at other accredited or state approved/licensed institutions once verified by the Academy Manager and approved by the Director. Up to 70% of credit hours for KAA may be transferred. Courses will be considered for transfer credit if relevant to the certificate program and completed with a grade of B or higher, or the equivalent if another grading system was used. Prerequisite and corequisite courses must meet the criteria set forth by KAA. Application and official transcripts must be submitted for all transfer credit approval. There is no credit given for any challenge examinations and achievement tests.

#### EXPERIENTIAL CREDIT

There is no credit granted for experiential learning.





#### FREQUENTLY ASKED QUESTIONS

#### How much does the program cost?

The tuition for each program is as follows:

- Holistic Ayurvedic Coach (HAC): \$3,650
- Ayurvedic Health Counselor (AHC): \$7,400 + the tuition for the AHC 2 Clinical Internship.
- Ayurvedic Practitioner (AP): \$8,750 + the tuition for the AP Clinical Internship. See the AP Clinical Internship section for tuition rates.
- Note: tuition does not include registration and management fees. See Tuition and Fees for each program for details.

#### If I enroll for AHC, will I get a HAC certificate?

Yes, since AHC covers all the curriculum of HAC within the AHC program, you will be eligible to receive the HAC certificate once all the requirements are completed.

# Are the programs approved by the Ayurvedic Accreditation Commission (AAC), and how do I get my NAMA membership?

- The HAC program is outside of the AAC competencies and not eligible for NAMA membership application.
- The AHC and AP programs provide an AAC Track designed to meet program competencies set forth by AAC. For eligibility to take the NAMACB exam as a Level I Ayurvedic Health Counselor or Level II Ayurvedic Practitioner, students must complete the AAC Track of KAA's respective programs. Completion of KAA's

programs does not guarantee NAMA professional membership. KAA offers program certificates which provide eligibility for the NAMACB Exams. Upon passing the Board Exam, individuals may apply for NAMA professional membership. For more information, please contact NAMA directly.

#### Do I need a college degree or a prior license/certification to study Ayurveda?

- No.
- KAA welcomes students from all educational backgrounds, with degrees, licenses or certifications in any field.
- Ayurvedic studies are especially complimentary to Certified/Licensed Practitioners in health-related fields including Yoga, Yoga Therapy, Massage Therapy, Chiropractic, Nursing, Naturopathy and Allopathic Medicine, etc.

# I'm not a healthcare professional. Can I still earn a certificate and practice Ayurvedic medicine?

- Yes! The minimum admissions requirement for our Ayurvedic Trainings is a high school diploma or equivalent.
- For AHC and AP applicants only Basic Anatomy and Physiology credits are also required. If you have not taken Anatomy and Physiology, you can finish the requirement within six (6) months of your start date. Kerala Ayurveda also offers an Anatomy and Physiology course. Inquire with Student Services for more information.

#### Does each state regulate the practice of Ayurvedic sciences?

- No.
- Ayurvedic practitioners are not licensed in the United States, and its practice is not
  regulated by state or federal agencies. Standards of competency are set by individual
  schools that have received state approval. Ayurvedic practitioners in the United States
  are advised on how to practice legally within a limited scope of practice so they are
  not viewed as practicing medicine without a license.
- We might say that Ayurveda's status in the US is analogous to the Chinese medical profession during its early years in the 1970s. While each state does not regulate the practice of Ayurvedic medicine itself, some aspects of Ayurvedic practice may spring within the scope of professions that are regulated. Students and graduates of the academy should be careful not to allow their practice to overlap one of those regulated professions unless they are licensed in that profession. Please contact your local state representative for more information about regulations in your area.

#### Is it legal to practice Ayurveda in all fifty states?

 A bill has been passed in eleven states (Arizona, California, Colorado, Idaho, Louisiana, Maine, Minnesota, Nevada, New Mexico, Oklahoma, Rhode Island) allowing the residents of those states to approach the non-licensed healing practitioners with informed consent.

#### Can I practice Ayurveda outside of the state where I receive my training?

Yes, Ayurveda is currently practiced all over the United States.

- While none of the US states currently have Ayurvedic practitioners or physicians as
  primary care physicians, many of these well-trained professionals utilize their
  education and skills in combination with other health care related credentials. Yoga
  Instructors, Massage Therapists, Registered Nurses, Nutritionists/Dietitians,
  Acupuncturists, Chiropractors, Medical Doctors and other health care professionals
  are recognizing and utilizing the benefits of educational training in Ayurveda.
- The AAC is currently working on developing educational standards, scope of practice, and related materials to support future licensing initiatives throughout the US.
- Many Academy graduates use their Ayurvedic education to enhance pre-existing professional careers.

Is there an Ayurvedic association which links other practitioners and students together? Yes, there is the National Ayurvedic Medical Association (NAMA). Many states have their own state associations such as the California Association of Ayurvedic Medicine (CAAM).

#### Is there an alumni association? Can I contact previous students?

- Once enrolled in our programs, students are welcome to join our private Student and Alumni Facebook group for community discussion and networking.
- Upon request, KAA can provide contact information of students for networking or informational purposes. Many of our students and alumni are happy to talk to prospective students and share their experiences.
- KAA has an online database for alumni services and information to assist community interaction and promote alumni practices to the public.

#### How many of your graduates practice Ayurvedic medicine?

- All our graduates can practice Ayurveda in their everyday lives for personal health.
   An understanding of Ayurvedic principles enriches the quality of life in all aspects, not just physical well-being. The study of Ayurveda is truly a healing transformation during which students find a new level of emotional, mental and spiritual Life. Additionally, graduates often change career paths or discover novel ways to apply their new Ayurvedic knowledge to their existing profession.
- There are many ways our students utilize their Ayurvedic education. Some of our students launch a practice as Ayurvedic Coaches, Counselors or Practitioners.
- Many of our graduates incorporate Ayurvedic knowledge in their current practice as healers, such physicians, nurses, yoga teachers and massage therapists. Ayurveda complements all other healing modalities.

#### Are there tests? I feel anxious about taking tests.

Please try not to feel anxious about the tests. Monthly testing is conducted online in our elearning system at the student's pace. There are (5) attempts available for taking the test, and the highest score is recorded. The tests provide the student and the academy an opportunity to verify learning benchmarks are achieved for successful course progress.

What materials do I need to bring to class and what should I expect in the classroom? Please bring a notebook and pen. If any textbooks are required for an individual session, you will be notified in advance. KAA provides all classroom facilities including any equipment used for panchakarma demonstrations, nutrition and herbology preparation. Equipment used for these classes include computers, monitors, video projectors, microphones, cameras, massage tables, linens, hotplates, towel warmers, vessels and utensils for cooking, shirodhara stand and vessels, and all perishable and nonperishable provisions used. Classes are taught in traditional, clean, well-lit classroom settings with tables and chairs for your comfort. A kitchen and restrooms are nearby the classroom.

#### Are there books for the class and what do they cost?

- Digital copies of our course manuals are included in the tuition for all programs.
- Print manuals are available at an additional cost. See individual Program Tuition and Fees for more information.

#### When can I visit the school? Do you have open houses or visitor events?

We allow our prospective students to sit in with the current class, so that they get a feel for the classroom setting and the topic. With a prior appointment, students are welcome to visit the academy and talk to the Academy Administrator. We are here to assist our students in any way we can.

#### What student services are provided?

Student mentoring is supported throughout the entire term of the program. On occasion, KAA posts job openings as they become available on group emails to students and alumni. KAA will do its best to help graduates to get into practice or a related career but there are no specific student services for career planning or job placement.
